With reference to your query, please note that as per the New Drugs and Clinical Trial Rules, 2019, it is mandatory that the EC involved in the review of biomedical and health research should be registered with the Department of Health Research through an online Naitik Portal (available at: <u>https://naitik.gov.in/DHR/Homepage</u>) and EC involved in the review of clinical trials should be registered with CDSCO through an online SUGAM portal (available at: <u>https://cdscoonline.gov.in/CDSCO/homepage</u>).

Also note that the institute should establish its own Ethics Committee (EC) if it is engaged in research on human participants but if your institute doesn't have its own EC and is utilizing the services of another institution, such as in this case the EC of Pushpagiri Institute of Medical Sciences & Research Center (host institution), the EC of the host institution should be registered with the Department of Health Research (DHR) and oversee the work of your institution.

Dear Sir,

This is with reference to your mail below, please refer to previous reply (attached file) from DHR side in this regard.

According to ICMR National Ethical Guidelines, 2017, an institution that does not have its own EC (user institution) may utilize the services of the EC of another institution (host institution) preferably in the adjoining/nearby area. Relevant requirements must be fulfilled before they do so.

The following requirements must be fulfilled by institutions that use the services of an EC from another institution:

1. The two institutions (host and user) should enter into an MoU for utilizing the services of the EC of the host institution or the user institution should provide a 'No Objection Certificate' and agree to be overseen by the EC of the host institution.

2. The EC of the host institution should have access to all research records including the source documents and research participants for continuing review of the implemented project, including site visits.

3. The EC of the host institution can undertake site monitoring and will have all the rights and responsibilities related to ethical review of the projects submitted by the user institutions.

It is always recommended to have independent EC under the Dental College, however this may be decided at institutional level depending upon the no of applications received annually from the Dental college.


