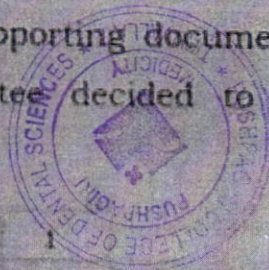

### ORDER

1. The Vice Principal, Pushpagiri College of Dental Sciences, Thiruvalla, in short the Dental College, has submitted the proposal of tuition fee and Hostel fee for Diploma in Dental Operation Room Assistance, for short the DORA, Course for the academic year 2019-20 along with the permission to conduct the DORA course obtained from the competent authorities.
2. The Fee Regulatory Committee, herein after referred as the Committee, scrutinised the proposal submitted by the Dental College and observed that the Dental College has requested to fix the tuition fee at Rs. 27,500/- for Government quota and Rs. 55,000/- for Management quota seats for DORA Course 2019-20. The Committee has also observed that though the Dental College has submitted the proposal for tuition fee in respect of DORA Course, they have not submitted any supporting documents to substantiate their demand. Therefore, the Committee decided to call for the supporting

documents to establish their claim. Accordingly, the Committee through Communication dated 02.07.2020, has directed the Principal of the Dental College to submit the relevant documents to substantiate the demand with the fee proposal in respect of DORA Course 2019-20.

3. In compliance of the above communication, the Vice Principal of the Dental College through communication dated 07.08.2020 has submitted certain documents, The Committee scrutinised the documents submitted by the Dental College and found that the documents submitted documents are insufficient for the regulation of tuition fee. However, the Committee verified the amount mentioned in the proposal with the other similar diploma courses and found that the demand of the Dental College for an amount of Rs. 27,500/- for Government quota and Rs. 55,000/- for Management quota seats are found reasonable. Therefore, the Committee decided to allow the tuition fee in respect of DORA Course at Pushpagiri College of Dental Sciences, Thiruvalla, as demanded by the Dental College for the academic year 2019-20.
4. The Principal, Pushpagiri College of Dental Sciences, Thiruvalla is hereby Permitted to collect an amount of Rs. 27,500/- for Government quota seats and Rs. 55,000/- for Management quota seats in respect of DORA Course for the academic year 2019-20. This fee shall be applicable for the ensuing two academic years also i.e. for 2020-21 & 2021-22 batches.

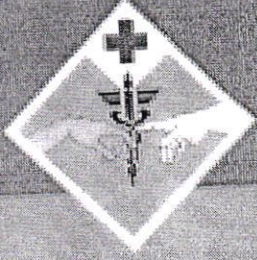

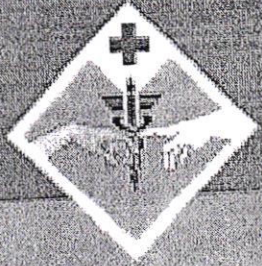
