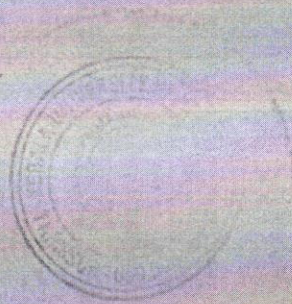

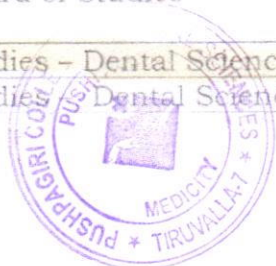

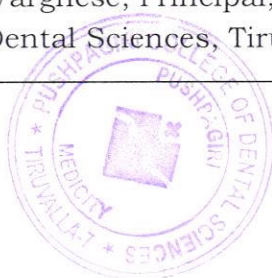

3.Due to the resignation of Dr Anil Kumar as Dean Faculty of Dental Sciences there exists a vacancy in the Faculty of Dental Science in the category under Section 30 ( 5 ) (iii) of KUHS Act 2010 and there exists a vacancy in the Board of Dental Science -UG in the category under Section 28 ( 2 ) (b) of the KUHS Act 2010. Further a new Dean for the Faculty of Dental Sciences has to be nominated under Section 13 (2) of the KUHS Act 2010,
